**ACTIVE INGREDIENT:** 0.005 % Bromadiolone

## ADVANTAGES:

- Contains second generation anticoagulant active ingredient.
- Larger surface to gnaw.
- Due to the hole in the middle it is easy to fix it into the feeding boxes.
- Fixing prevents carry away.
- Consumption can be easily determined from the chewing marks.
- The wax content of the formulation allows rodent control in food factories.
- Coloured bait with bittering agent, Bitrex, to avoid accidental consumption by humans and domestic animals.

## GENERAL INFORMATION:

This second generation anticoagulant rodenticide generally kills rodents after a single consumption. Death of rodents sets in 4-5 days after the start of consumption. The total elimination of all rodents is to be expected within 1-2 weeks depending on the size of the area and the level of infestation. Suitable quantity of poisoned bait should be provided leaving enough feed to every rodent, even in case of high infestation.

## DIRECTION OF USE:

The rodenticide wax block should be placed out in feeding-boxes near burrows, runs and hiding places of rodents. Feeding-places must be established out of reach of children and domestic animals. Depending on the infestation level 1-2 blocks should be placed in the feeding-boxes (or depending on the size of the feeding-box). Place the feeding boxes 4-10 meters apart. The block should be fastened onto the pike inside the feeding-boxes. Check the product regularly every 7-10 days and replace if the box is empty. Replacements are to be continued until the total elimination of rodents. Spoiled baits should be removed immediately and replaced by fresh product.
